In view of above, it has been decided to introduce Annual Preventive Health Check-up for Insured Persons (IPs) of age 40 years and above. The health check-up, besides routine General Physical/Clinical Examination, will include the following investigations:

- 1. Hb, TLC, DLC, ESR
- 2. Random Blood Sugar
- 3. Kidney Function Test Blood Urea, S.Creatinine
- 4. Liver Function Test-S. Bilirubin, SGOT, SGPT, S.Alk. Phosphatase.
- 5. Urine-Routine and Microscopy.
- 6. X-ray chest PA view
- 7. ECG

The Annual Preventive Health Check-up for Insured Persons will be conducted in all ESIC/ESIS Hospitals/equipped dispensaries.

The health profile/record of each such IPs may also be uploaded in Electronic Health Record of the patients.
